To whom it may concern,

In January of 1980 I passed a kidney stone at Lake Tahoe during a ski trip. Upon returning to Miami my personal physician, Dr. Marvin Meitus, sent me to Mt. Sinai Hospital for an ultra sound test which confirmed the presence of 5 large stones in my kidney. He recommended that I see Dr. Rolly Kohen, head of Urology at Mt. Sinai. Dr. Kohen saw me and recommended that they do a lymphotomy, which was then scheduled to take place in three weeks.

I happened to mention to a friend, Christina Collins, that I was concerned about the upcoming surgery and she suggested that before I go ahead with the surgery I should speak to Ysatis De Saint-Simon, a psychotherapist who had helped her get rid of a serious lung infection. Her condition was chronic, continuing to remain even after repeated treatments of massive doses of antibiotics. After her therapy with De Saint-Simon her infection was completely gone.

I made an appointment with De Saint-Simon and asked her if she thought we could dissolve the kidney stones the same way as Christina's lung infection. She asked me when my surgery was scheduled and I told her that it was to be done in three weeks. She indicated that that was a very short time and we could only do it with intensive therapy, although she couldn't promise anything since it was such a short time.

We began intensive therapy immediately aimed at getting to the root cause of the problem and removing it by means of hypnotherapy and regression therapy, as well as many hours spent listening to a tape cassette designed to reinforce those therapy sessions.

He was amazed to find that my kidney stone problem was completely cleared up and said that he couldn't understand it. I didn't try to explain it either as I'm sure he wouldn't believe it anyway.

The whole process has gone a long way towards helping me to appreciate the mind-body connection.

The patient is a middle aged white male who was admitted for further investigation of a filling defect in his right renal pelvis.

He had previously passed a renal calculi and had recent passage of gravel with hematuria. He was seen in the office. An IVP was done showing a filling defect in his right renal pelvis that was thought to be a nonopaque stone. He was subjected to nephrotomogram as well as sonography showing tissue as opposed to stone, and for this reason retrogrades were recommended.

A right retrograde was done showing the filling defect had disappeared. We now assume that the filling defect was caused by a blood clot in his right renal pelvis due to the passage of a stone. He had no cystoscopic reaction and was discharged to be followed in the office having been given proper instructions.

FINAL DIAGNOSIS: 1. Normal right kidney.

OPERATION PERFORMED: 1. Cystoscopy retrograde.
